Since 2000, 65 Florida cities, towns and counties have signed onformally committed to the Department of Elder Affairs' *Communities for a Lifetime* (CFAL) Initiative. These participating communities have committed themselves to creating a better place for older adults to live by providing all residents with the opportunity to achieve their full potential and contribute to the betterment of their communities. During the initiative's first three years, it has evolved based on the input of aging network professionals and participating communities.

First, thank you for your efforts in enlisting the support of communities and working with county and city staff members as they learn about aging services and helpful opportunities and services for older adults. Area Agencies on Aging (AAAs) are active partners with the Department of Elder Affairs in efforts to encourage local government support of the CFAL initiative. This communication serves to strengthen that partnership, to provide you an update on the initiative and to inform you of some new tools we have developed.

***Communities for a Lifetime* Web Site and E-mail**

We have developed a CFAL Web site that outlines guidelines for conducting a community-wide inventory of opportunities and services available to older adults that can help a person maintain independence throughout a lifetime. The CFAL Web site is a "work in progress." We welcome submissions of information and have included details with this transmittal about how you can submit information for consideration to be included on the Web site. The site also features an e-mail address—communities@elderaffairs.org—for visitors to make inquiries about the initiative.

Communication Procedures

In order to ensure that the Department and AAAs have a coordinated effort of outreach and support to communities, we are providing the following guidelines for communication and correspondence:

- *Presentations.* In order to keep you informed about our communication with communities, we will notify each AAA executive director of any CFAL presentations or visits DOEA staff make within the PSA.
