Identification of Three Top Accomplishments

1 Type of Development: 1. Public Education/Awareness

At the 2019 Florida Senior Day event, the Florida Department of Elder Affairs (DOEA) expanded programming to include a new Senior Day Forum with a panel led by DOEA Secretary Richard Prudom to discuss sisues facing Florida's seniors, their families, caregivers, and Florida's Aging Network. Type of Development: 5. Policy development

This year, Secretary Prudom updated DOEA's mission and vision to increase awareness of the importance of Florida's older adults and caregivers. The new mission is to promote the health, safety, and independence of Florida's seniors, their families, and caregivers. The updated vision is for al Floridans to live well and age well. The intention of this change was to more formally declare DOEA's commitment to supporting the millions of important and selfless caregivers across Florida – more than 2.9 million – who make numerous searcifices to care for others. One souring the needs of seniors continue to be met. In July 2019, Elder Affairs increased the basic subsidy for caregivers each month through the Home Care for the Elderly (HCE) Program. The subsidy had not been updated in more than 20 years and is essential to offset expenses for providing support and maintenance of the elder for whom they care. The Department went through the rule promulgation processes to increase the payment. Additionally, DOEA changed its policy to allow clients to be dually enrolled in HCE and the Statewide Medicaid Managed Care Long-term Care Program (SMMC LTC), which now permits existing HCE clients who are released for SMMC enrollment to also keep their basic subsidy caregiver benefit if they choose. To better server Florida's older adults, the Community-Dased services to meet the needs of functionally impaired elders, also received an update. Following a program evaluation, it was determined that some clients were terminating their services due to the inability to pay copayments established in the program. In order to better serve seniors, DOEA updated the co-pay policy for CCE and ADI clients to ensure continued services to clients who are unable to pay. Effective July 2019, no co-payments are assessed on any CCE or ADI client whose income is at or below the federal poverty level. Additionally, no CCE or ADI client may have their services terminated for inability to pay their co-pay. To address the issue of senior hunger in Florida

Type of Development: 6. Legislative development

During Older Americans Month (May 2019), DOEA's Secretary Richard Prudom was invited to present before the U.S. Senate Select Committee on Aging to discuss Florida's strong Aging Network. The purpose of the committee hearing was to discuss reauthorization of the federal Older Americans Act and to highlight all that Governor DeSantis is doing to make Florida the best place for older adults and their families. Florida was selected for our many innovative ways to serve the growing and increasingly diverse senior population, and the Department was highlighted as a model for other states to follow. The Committee was especially interested in our Age-Friendly efforts, Governor DeSantis's efforts to combat dementia, and DOEA's Dementia Care and Cure Initiative. Locally, organizations in Florida's PSA have made notable strides in building support for programs that benefit older adults. The AAA in PSA 6, for example, has created an advocacy brochure for members of the Florida Legislature to highlight the importance of funding home-based services for frail and vulnerable older adults who can no longer remain safely at home without some assistance. The mailer compared the modest cost of providing such basic services as housekeeping assistance and home-delivered meals to the significantly more expensive cost of placing someone in a Medicaid-funded nursing facility. The AAA in PSA 11 participated with other elder-serving organizations in an Older Adult Advocacy Task Force, convened by the United Way of Miami-Dade. The taskforce seeks to educate the general population, as well as elected officials, about the growing need for services for older adults. In May, the taskforce organized a Stand Up for Older Adults Forum, and nearly 90 leaders came together to lay the groundwork for more collaborative advocacy and "consciousness raising."

SECTION IV. Developmental Accomplishments B. For A System of Elder Rights

Stopping the abuse, neglect, and exploitation (ANE) of seniors and vulnerable adults is an integral part of Livable Florida – DOEA's statewide efforts to make Florida a place where older adults can live well, and age well safely and free from abuse. Social isolation is a major factor that can increase the vulnerability of an elder. DOEA has been working with communities through the Livable Florida initiative to help prevent social isolation and, therefore, reduce exploitation. DOEA has expanded its focus on World Elder Abuse Awareness Day (WEAD), recognized internationally each year on June 15. In his Bolder, Brighter, Better Future Budget Recommendations, Governor DeSantis has recommended \$160,000 in increases to fight abuse, neglect, and exploitation through Livable Florida and the expansion of WEAD activities and outreach. Locally, the AAAs and other partners in Florida's Aging Network offered information and assistance as part of their strategy to increase public awareness and education of elders' rights. For example, the AAA in PSA 3 sponsored advertisements for their elder abuse and increased elder abuse prevention awareness through public service announcements on the radio and in newspapers, and distributed elder abuse awareness information to attendees at meal sites, community centers, and other organizations that serve the public and senior populations. The AAA in PSA 9 has focused during the past year on establishing regular participation in various task forces, coalitions, and multidisciplinary team meetings in the community related to elder rights and elder abuse/neglect/exploitation. These teams work in various ways on outreach, public education, prevention, and resolution of crimes against older adults and develop coordinated community responses involving various stakeholders. AAA in PSA 5 provided workshops to educate and bring awareness of the legal rights of Florida seniors and veterans. The information provided can help seniors protect themselves from frauds and scams, and helped veterans and

Type of Development: 2. Resource Development

In March, Governor Ron DeSantis highlighted some of his key initiatives that support Floridians living with Alzheimer's disease and related dementias (ADRD) and their caregivers. One of the Governor's initiatives was to add a section in the State Health Improvement Plan (SHIP) that is exclusively devoted to ADRD. It was important to include ADRD in Florida's SHIP because Alzheimer's is the sixth leading cause of death in Florida, yet it was not directly addressed by the SHIP (although each of the other top 10 causes of death were addressed by the SHIP). The Alzheimer's Association projects there are 560,000 Floridians living with Alzheimer's disease – a number (which does not include those living with other forms of dementia) that is expected to increase to more than 720,000 by 2025. DOEA partnered with the Alzheimer's Association and the Florida Department of Health, and ADRD has been added as a priority area in the SHIP. Thanks to the vision of Governor DeSantis and Lieutenant Governor Jesanette Nuñez, Florida is the only state in the nation to have a priority area in its SHIP devoted exclusively to the care of those living with ADRD and their caregivers. The subcommittees of the new priority area workgroup have implemented the strategies and objectives in the SHIP to ensure that Florida is a place where all Floridians, including individuals living with ADRD, their families, and caregivers, can live and live well. Goals of the ADRD priority area include the following: 1) Challenging each of the institutions that house Memory Disorder Clinics (MDCs) in Florida to provide matching funding annually to the MDCs to allow for an increase in the number of individuals they serve with evaluation and diagnostic testing for ADRD; and 2) Directing the Florida Department of Health to apply to the Centers for Disease Control and Prevention to become an Alzheimer's Clare and Cure Initiative (DCCI). As of November, DCCI now has active task forces in all of Florida's 11 PSAs, and there are 14 total task forces. The Department

Type of Development: 5. Policy development

Currently, there are more than 5.5 million residents age 60 or older in Florida, and by 2030, this population will increase to 7.6 million – an increase of more than 38 percent. The communities that will thrive in Florida will be those that both tackle the challenges and embrace the positive possibilities that an aging population creates – essentially becoming livable communities. The amenities of a livable community help to maximize the independence and quality of life of older adults, while also enhancing the economic, civic, and social vitality of the community. An important initiative at DOEA is Livable Florida – working with AARP on making Florida an "Age-Friendly State." In April, Florida became the fourth state in the nation, and the first state in the Sun Belt, to join AARP's Network of Age-Friendly States and Communities (Network). In embracing the Age-Friendly designation, Governor Ron DeSantis envisions a Florida where older adults, and indeed all Floridians, are thriving in livable communities where they not only live but live well and age well.Age-Friendly states and communities address the social determinants of health – the conditions in which people are born, grow, live, work, and age. The social determinants of health include factors such as socioeconomic status, education, appropriate and affordable housing, neighborhood and physical environment, employment, and social support networks, as well as access to health care. There are now 35 communities in Florida – 21 cities, three villages, two towns, and nine counties – that have joined the Age-Friendly Network. Not only will those communities be building on that momentum, but others will be joining them in 2020 in creating a Livable Florida. As just one example among many, the AAA in PSA 11 is working on its Age-Friendly Miami-Dade initiative to collectively address issues of importance to older adults. In 2019, Secretary Prudom also conducted regional symposia with organizations from Florida's Aging Network. The meetings served as forums for i
